Dear Members,

We are very pleased that you would like to become a member with us. However, we would like to point out an important regulation regarding membership in SV Diesenbach: Membership in the association is a valid contract and is subject to the same conditions as all other contracts concluded within the legal framework. Therefore, our membership also involves a contractual obligation that can only be terminated under certain conditions.

Notice Period and Termination Conditions:

- Membership can only be terminated at the end of a quarter.
- A notice period of 4 weeks before the end of the quarter is required. The termination must be received at least 4 weeks before the end of the quarter.
- If the termination is not made on time, membership will remain valid until the end of the following quarter.
- The membership fee will be charged in the month following the quarter, retroactively for that quarter.

The membership is as valid as any other contract concluded within a legal context. If the termination conditions are not followed, the same consequences as with other contracts (e.g., payment obligations) may apply.

We kindly ask you to consider these regulations to avoid any misunderstandings. If you have any questions, we are happy to assist you.

Important note on data protection

The data requested in the declaration of membership is collected in order to establish the contractual relationship between you and SV Diesenbach in accordance with the articles of association of SV Diesenbach (legal basis Art. 6 para. 1 b GDPR).

Your data will be deleted after the of the statutory retention periods.

Depending on the requirements of the responsible sports association and the Bavarian State sports association, data must be forwarded to the associations. The other data is only passed on to third parties (e.g. department heads, team managers) insofar as necessary for sporting operations and social maintenance in accordance with the statutes are necessary.

Data will not be passed on to third parties in any other way.

According to the General Data Protection Regulation, you have the following rights:

If your personal data is processed, you have the right to information about

the data stored about you (Art. 15 GDPR). If incorrect personal data, personal data are processed, you have the right to rectification (Art.16 GDPR).

If the legal requirements are met, you can request the deletion or restriction of processing and to object to the processing of your personal data. SV Diesenbach 1976 e.V. would like to point out that the board must refuse to accept members if they do not agree to the data protection declaration.

Data protection/personal rights

Consent to the publication of photos and personal data.

For this purpose we would like to use photos from club life in which you or your children may be individually recognizable. For legal reasons ("right to your own image"), this is this is only possible with your consent, unless there is a general exception to the consent requirement (images from the field of contemporary history, images in which the person only appears as an in which the person appears only as an accessory and pictures of gatherings sporting events and processions).

A picture is mandatory for electronic player passes required.

For consent to the publication of photos and personal data please sign the relevant section in the declaration of membership.

Should you do not sign, we will assume that you do not wish any publications.

Right of revocation

An objection to the storage/administration of your data and to the publication of publication of photos can be made in writing at any time for the future, not for the past.
